I certify that I completed the “Return to Campus Safely” training on Bridge and attest that:

- I understand that this is a challenging time for everyone. I pledge to show respect and kindness to others.
- I will only come to campus if I am healthy and ALL of the following:
  - I have not had a fever for at least 72 hours.
  - I do not have any other flu-like symptoms (for example cough, shortness of breath).
  - At least 10 days have passed since the date my symptoms first appeared.
  - I have not had contact with anyone who is COVID positive for 14 days.
- I will maintain appropriate social/physical distance and ALL of the following:
  - I will maintain at least 6 feet of separation as often as possible. If this is not possible, then I will wear a face covering, as required by university guidelines.
  - I will minimize face-to-face contacts and avoid large gatherings.
  - I will limit in-person interactions to less than 50 people, while maintaining 6 feet of separation as much as possible.
- I am required—except in approved circumstances—to wear face coverings and understand the following:
  - Face coverings are required in all common areas such as hallways, restrooms, lounge areas, classrooms, conference rooms, etc.
  - The primary purpose of wearing a face covering is to prevent the spread of the disease by those with the virus.
  - In certain cases, the use of a face covering is not advised, such as in the case of people with respiratory conditions. These cases should be addressed on a case-by-case basis with the individual’s supervisor and if necessary with the UHRM/ADA Coordinator.
- I will practice good hygiene, including the following:
  - Wash hands often with soap and water for at least 20 seconds or use hand sanitizer with at least 60% alcohol if soap and water are not available.
  - Avoid touching my eyes, nose, and mouth with unwashed hands.
  - Cover my mouth and nose with a tissue when I cough or sneeze, or use the inside of my elbow.
  - Practice routine cleaning and disinfection of frequently touched objects and surfaces in my workspace such as handrails, doorknobs, desktops, workstations, keyboards, and phones.
  - Avoid using other employees’ phones, desks, offices, or other work tools and equipment, when possible. Clean and disinfect them before and after use.

- I will report potential COVID-19 exposure, pending test results, or a diagnosis to my supervisor immediately.
- My temperature may be checked daily upon returning to campus and I understand that if my temperature is at or above 100.4° F, I will not be allowed to work on campus.
  - My department/college may create guidelines to check my temperature daily on campus.
  - I could be required to take my temperature daily at home prior to returning to campus.
- If I receive a test for COVID-19, I will also report pending, negative, and positive test results on the University's COVID-19 Case Reporting Form at [coronavirus.utah.edu/covid19-case-reporting/](https://coronavirus.utah.edu/covid19-case-reporting/).
- I will not report to work and will notify my supervisor before my shift if my symptoms change.
